

INVITATION FOR REQUEST FOR PROPOSAL (RFP)

- 1.1 **Introduction:** LMRCL invites Tender for selection of Licensee for Advertisement rights in Trains of LMRCL Phase IA (corridor section).
 - a. Lucknow Metro Rail Corporation Limited (LMRCL) is a joint venture of the Government of India (GoI) and the Government of Uttar Pradesh (GoUP) for the construction and Operation of Metro Rail in the Lucknow city with loan assistance from European Investment Bank (EIB).
 - b. Lucknow Metro Phase 1A comprises of a distance of 22.878 kilometres from CCS Airport to Munshi Pulia. It will have 21 stations including 4 underground stations.
 - c. Out of Lucknow Metro Phase 1, Metro Train operation will be started first in the Priority Section. **Priority Section** comprises of elevated section from Transport Nagar to Charbagh (approx 8 km) which includes 8 stations.
- 1.2 LMRCL invites bid from interested parties for selection of Licensee for exclusive Advertisement Rights of Lucknow Metro Trains to design, procure/manufacture, install, manage, operate, market and sell advertising spaces for Lucknow Metro Trains in LMRCL Network. LMRCL shall receive RFP Bids pursuant to this RFP document, in accordance with the terms set forth herein as modified, altered, amended and clarified from time to time by LMRCL. Bidders shall submit bids in accordance with such terms on or before the date specified in this document. Bidders are advised to visit the LMRCL premises and familiarize themselves with the proposed advertisement arrangements and all activities necessary in this regard.
- 1.3 LMRCL has adopted a single-stage two packet Bidding Process for selection of a suitable highest bidder to grant Exclusive Advertising Rights of Lucknow Metro Trains in Priority Section of LMRCL Network of Phase-I
- 1.4 Request for Proposal Document (non-transferable) can be obtained from the O/o-Chief Engineer/Contract, Administrative Building, Vipin Khand, Gomti Nagar, Lucknow-226010. Cost of RFP Document (Non-refundable) is Rupees Five Thousand Two Hundred and Fifty only (Rs.5,250/- including UPVAT). RFP Document cost shall be submitted in the form of Demand Draft / Pay Order drawn on any Indian Scheduled bank/ Indian Branch of foreign bank in favour of Lucknow Metro Rail Corporation Limited payable at Lucknow. Late/ delayed RFP received after the stipulated date and time of submission of RFP shall be rejected out rightly.

1.6 Schedule of Various Stages: The Licensee shall follow the following time lines:

1.7 **Bid Security:** The Bidder shall submit with his bid, a Bid Security for the sum mentioned in 1.5 (2) above in the form of:

- Irrevocable bank guarantee issued by a Scheduled Commercial bank (including scheduled Commercial Foreign Banks) in India in the form given in Annexure-4.
- ii. An irrevocable Letter of Credit
- iii. Demand Draft/ Pay Order in favour of Lucknow Metro Rail Corporation Ltd. payable at Lucknow from a Scheduled Commercial bank based in India.

The bid security shall be submitted in a sealed envelope clearly marked on top "Bid Security for RFP No- LKAR-02". The Bid Security shall remain valid for a period of 56 days beyond the validity period for the Tender.

1.8 The Tender Document submitted without bid security shall be out rightly rejected. The bids received after stipulated date and time of submission of Tender Document shall be rejected out rightly.

1.9 Minimum Eligibility Criteria:

- 1.9.1 Annual Average Turnover (T4): Bidders shall have a minimum annual average gross turnover of Rs. 20 Lakhs from advertisement sector(s) in last 3 (three) audited financial statements certified by Charted Accountant with stamp & signature.
- 1.9.2 In addition to above, the tenderer should have executed atleast one advertisement work in metro trains/ railway trains also.

Notes:

- Financial data for latest last three audited financial years has to be submitted by the tenderer in Annexure-5 along with audited balance sheets. The financial data in the prescribed format shall be certified by Chartered Accountant with his stamp and signature. In case audited balance sheet of the last financial year is not made available by the bidder, he has to submit an affidavit certifying that 'the balance sheet has actually not been audited so far'. In such a case the financial data of previous '2' audited financial years will be taken into consideration for evaluation. If audited balance sheet of any year other than the last year is not submitted, the tender will be considered as non-responsive.
- While calculating the updated value of turnover, escalation of 5% per annum shall be considered for firms based in India and 2% for foreign based firm.
- The tenders for this contract will be considered only from those tenderers (proprietorship firms, partnerships firms, companies or corporations) who meet requisite eligibility criteria prescribed in the sub-clauses of clause 1.9.1 of NIT. <u>Joint Ventures and consortiums are</u> not allowed to participate in the tender.
