### **1.1 GENERAL**

#### **1.1.1 Name of Work**

- i) Uttar Pradesh Metro Rail Corporation Ltd (UPMRCL), a 50:50 jointly owned Company of Government of India and Government of Uttar Pradesh has been reconstituted as per the approval of the Government as single SPV by rechristening it as “Uttar Pradesh Metro Rail Corporation Ltd (UPMRC)” for implementation of Metro Rail projects in various important cities in the State of Uttar Pradesh and has been entrusted with the responsibility of implementation and operation of the rail based Mass Rapid Transit System (Metro) in Kanpur and Agra cities where Metro projects have recently been approved by Government of India.
- ii) Uttar Pradesh Metro Rail Corporation Limited hereby invites proposals for **“Reconfiguration of legacy ERP Application, integration with existing custom HRMS module and 5 year comprehensive Annual Maintenance and Support for Uttar Pradesh Metro Rail Corporation Ltd”**.
