## NOTICE INVITING TENDER (NIT)

## 1.1 GENERAL

Uttar Pradesh Metro Rail corporation (UPMRC) Invites Open tender through e-tendering system (i.e. Technical and Financial bid) from eligible applicants who fulfill qualification criteria as stipulated in clause 1.2.2 of NIT for "Design, supply, installation, testing & commissioning of AFC system by Re-Engineering the existing Lucknow Metro closed loop system for implementation of Open Loop EMV NCMC card and QR Code ticketing."

Brief scope of the work and site information is provided in ITT clause A2 & Employer's Requirement.
