

### **3. NOTICE INVITING TENDER**

- 3.1** Uttar Pradesh Metro Rail Corporation Ltd. (UPMRC) has successfully commenced its services on entire North-South Corridor from CCS Airport to Munshipulia consisting of 21 Nos. Metro Stations with total stretch length of 23 km from 9<sup>th</sup> March 2019 in Lucknow. UPMRC has crossed the total ridership of approx. 70000 on the very first day of its complete commercial run and it is on a rise.
- 3.2** In order to fulfil its mandate to raise non-fare revenue, UPMRC invites open e-tenders on two packet system from interested parties which may be a sole proprietorship firm, a partnership firm or a company having registered office in India and incorporated under the company act 1956/2013, for selection of licensee for granting the license for ‘Licensing of space on pillars N-S Corridor of Uttar Pradesh Metro Rail Network in Lucknow for placement and operation of telecom equipment along with laying of Optical Fibre Cable (OFC) for Providing Shared Mobile (Cellular) Coverage (2G/3G/4G/5G)’. UPMRC shall receive E-Bids pursuant to this RFP document, in accordance with the terms set forth herein as modified, altered, amended and clarified from time to time by UPMRC.
- 3.3** Bidders shall submit Tender/bids in accordance with such terms and conditions on or before the date specified in this document. Bidders are advised to visit the UPMRC premises at the respective station / site and familiarise themselves with various arrangements and all activities necessary in this regard.

- The Bid security amount shall also be submitted in the form of Demand Draft (DD) drawn on any Indian Scheduled Bank in favor of “Uttar Pradesh Metro Rail Corporation Limited” payable at Lucknow.
- The Bid shall be summarily rejected if it is not accompanied with valid bid security of appropriate amount.
- The bid security/EMD in original physical form must invariably be submitted to

UPMRC by the stipulated time frame as given in clause 3.4(v) of NIT, failing which the bid is likely to be rejected.

- The bid security of the Selected Bidder shall be adjusted against the Interest Free Security Deposit (IFSD). The bid security (submitted towards the bid/tender) of unsuccessful bidders/tenderers, shall be refunded within 90 days after award of contract, without considering any interest, thereof. If the bidder withdraws its bid at any stage, UPMRC shall have the right to forfeit the bid security amount of the bidder.

**3.6 Schedule of Various Stages:** The Licensee shall follow the following timelines:

**3.6 Eligible Applicants:**

Tenders for this contract will be considered only from those tenderers (proprietorship firms, partnerships firms, companies, corporations,) who meet requisite eligibility criteria prescribed in the Clause 3.7 below. **Joint Ventures/Consortiums are not allowed to participate in the bidding process.**

- A tenderer shall submit only one bid in the same tendering process.
- Tenderers shall not have a conflict of interest. All Tenderers found to have a conflict of interest shall be disqualified. Tenderers shall be considered to have a conflict of

interest with one or more parties in this bidding process, if: participation by a bidding firm or any of its affiliates that are either involved in the consultancy contract to which this procurement is linked; or if they are part of more than one bid in the procurement; or if the bidding firm or their personnel have relationships or financial or business transactions with any official of procuring entity who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) bidder from the procuring entity with an intent to gain unfair advantage in the procurement process or for personal gain.

**3.7 Eligibility Criteria: -**

**3.7.1 Average Annual Turnover of the bidders during the last three years ending 31<sup>st</sup> March of the previous financial year should be at least 24 Lakhs. The Bidder shall submit audited financial year data of last three years (i.e. FY 2019-20, 2020-21 and 2021-22) certified by Chartered Accountant with stamp & signature along with UDIN.**

\*In case audited Balance sheet of the last financial year is not made available by the bidder, they have to submit an affidavit certifying that the balance sheet has actually not been audited so far, in such a case financial data of previous 2 years will be taken into consideration for evaluation.

3.7.2 The Bidder must be registered with Department of Telecommunications, Government of India as authorized Infrastructure provider in IP-1 category

**3.8 Brief scope of work is mentioned as below:-**

a) **679 no. pillars** are available along the central median of the elevated section (excluding pillars under station boxes) of N-S corridor of UPMRC network at Lucknow for the installation of telecom equipment for providing shared mobile (cellular) coverage (2G/3G/4G/5G).

b) The Phase-1A corridor of UPMRC Network in Lucknow (**about 22.87 Km**) consisting of 17 elevated stations and 4 underground stations is available for laying of Optical Fiber Cable (OFC).

**3.9** License period shall be for a period of Six (06) years from commencement of license fee.

**3.10** The license may be extended by three (03) years on successful completion, to the complete satisfaction of UPMRC, of initial 06 (Six) years on mutually agreeable terms & conditions.

**3.11** The intending tenderers must be registered on e-tendering portal <https://etenders.gov.in/eprocure/app> . Those who are not registered on the e-tendering portal shall be required to get registered beforehand. After registration, the tenderer will get user id and password. On login, tenderer can participate in tendering process and can witness various activities of the process.

**3.12** The authorized signatory of intending tenderer, as per Power of Attorney (POA), must have valid Class-II or Class-III digital signature. The Bid document/RFP can only be

downloaded or uploaded using Class-II or Class-III digital signature. However, the tenderer shall upload their tender on <https://etenders.gov.in/eprocure/app> using class-II or class-III digital signature of the authorized signatory only.

- 3.13** Tender submissions shall be done online on <https://etenders.gov.in/eprocure/app> after uploading the mandatory scanned documents towards cost of tender documents and bid security such as scanned copies of transaction of payment i.e. RTGS, NEFT & IMPS or DD/Bank Guarantee submitted against the bid security amount and other documents as stated in the tender document. Instructions for online bid submission are furnished hereinafter.
- 3.14** Submission of Tenders shall be closed on e-tendering website of employer at the date & time of submission prescribed in NIT after which no tender shall be accepted. It shall be the responsibility of the tenderer to ensure that his tender is submitted online on e-tendering website <https://etenders.gov.in/eprocure/app> before the deadline of submission. The Employer shall not be responsible for any delay, difficulties and/or inaccessibility of the downloading and/or uploading facility from the e-procurement portal for any reason whatsoever.
- 3.15** DELETED.
- 3.16** UPMRC reserves the right to accept or reject any or all proposals without assigning any reasons. No tenderer shall have any cause of action or claim against the UPMRC for rejection of his proposal.
- 3.17** Tenderers are requested to visit e-tendering portal <https://etenders.gov.in/eprocure/app> regularly for any Employer's issued clarifications, addendum, corrigendum and/or due date extensions.
- 3.18** After successful completion of tender processing, the Letter of Acceptance to the successful bidder shall be uploaded on the e-tendering portal <https://etenders.gov.in/eprocure/app> which can be downloaded by successful bidder. LOA would also be E-mailed to the successful bidder.
- 3.19** In case at a subsequent date the successful bidder/licensee is found to have been banned for business, UPMRC shall be at liberty to and have full right to cancel the LOA/ License Agreement and forfeit the interest free security deposit in favour of UPMRC after adjusting any dues payable by the licensee.
